ALL YOUTH ORIGINALLY ENTER CLNY VIA THE HGA PROGRAM. A CITY LIVING SOCIAL WORKER DOES AN INITIAL CONSULTATION TO DETERMINE THE YOUTH'S HOUSING STATUS AND HOME GOODS NEEDS. DURING THIS INTAKE, WE ALSO DISCUSS THE YOUTH'S LONG-TERM GOALS AND OBJECTIVES, SUCH AS EMPLOYMENT, EDUCATION AND COUNSELING NEEDS TO ASSESS IF THE YOUTH WOULD LIKE ASSISTANCE WORKING ON THESE GOALS IN THE NEXT THREE MONTHS. IF THE YOUTH IS NOT INTERESTED IN PURSUING GOALS BEYOND HOUSING STABILITY, HE/SHE REMAINS IN HGA AND RECEIVES HOUSING SUPPORT FROM OUR SOCIAL WORKERS. FOR OUR NON-COLLEGE ENROLLED YOUTH, WE MAKE REFERRALS TO APPROPRIATE HIGH SCHOOL EQUIVALENCY OR VOCATIONAL PROGRAMS AND HELP
